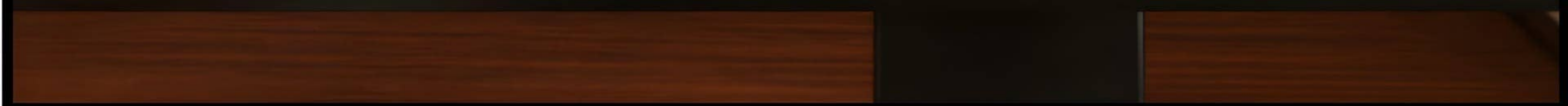
Julie wrecked the new car she'd purchased, (according to her) made finding and keeping a decent job a challenge.

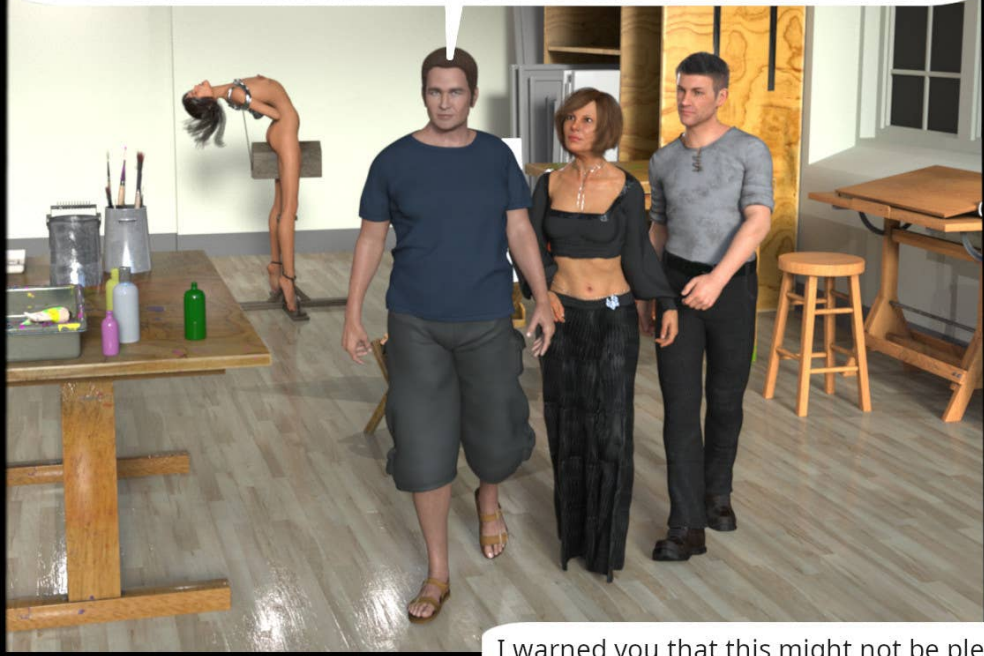


We'll see our daughter.

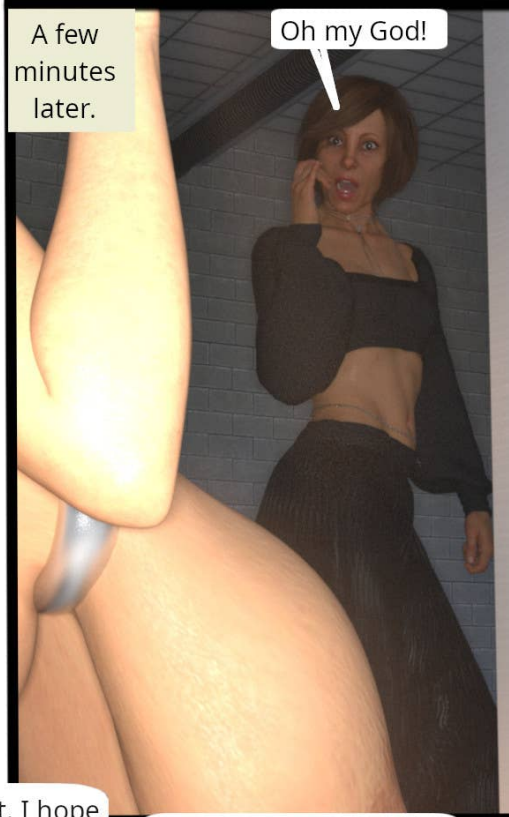


Very good, then. Follow me.

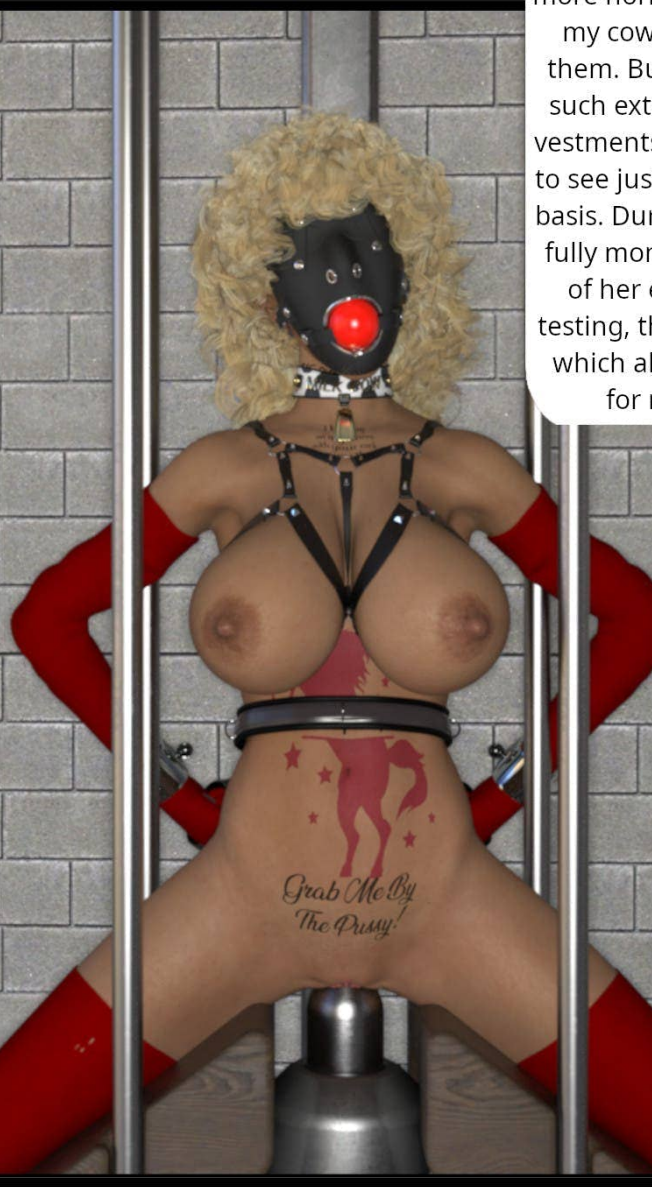
What is the purpose of this... testing?
