

It is possible that Rin provided false information to mislead the investigation.

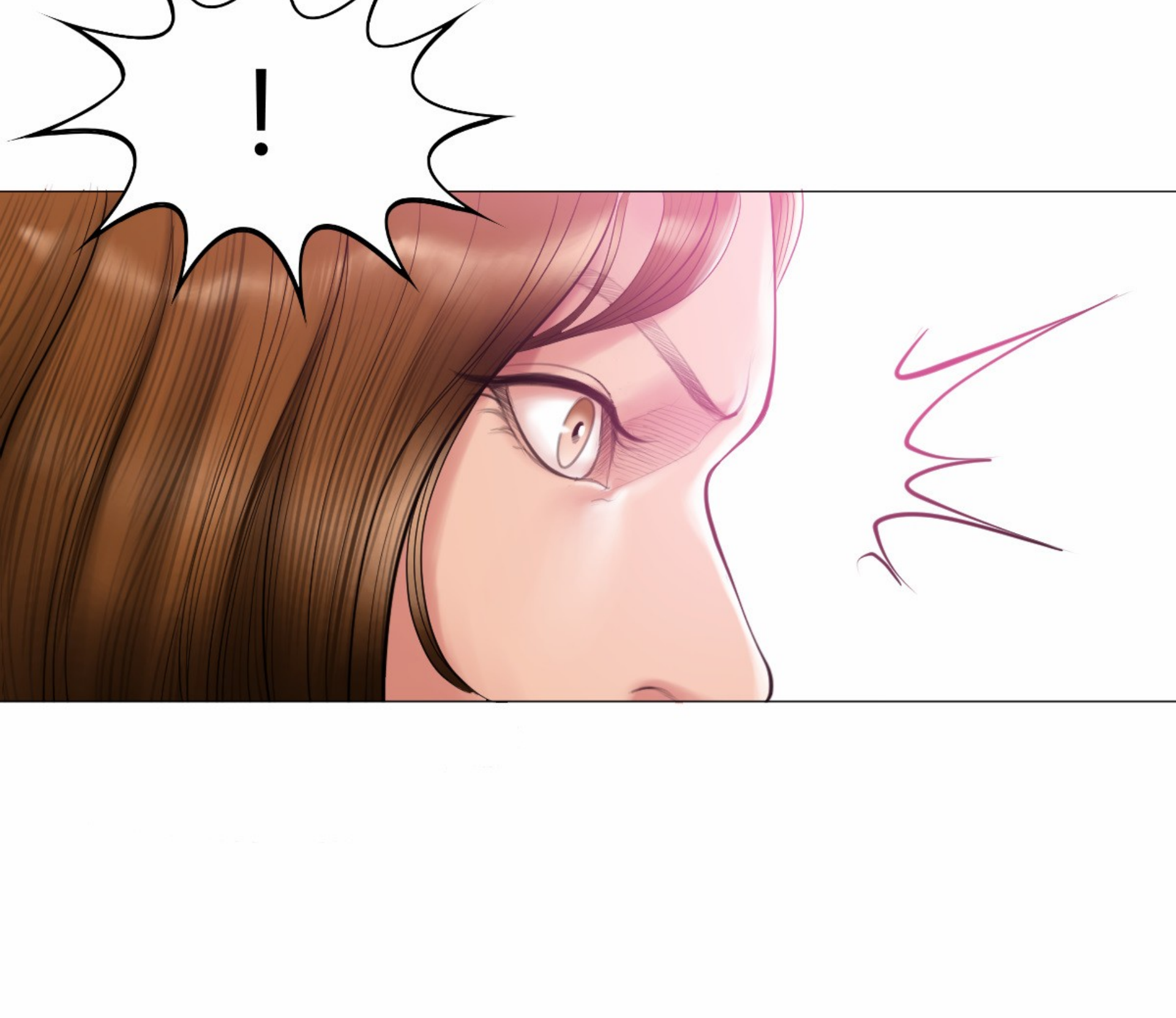
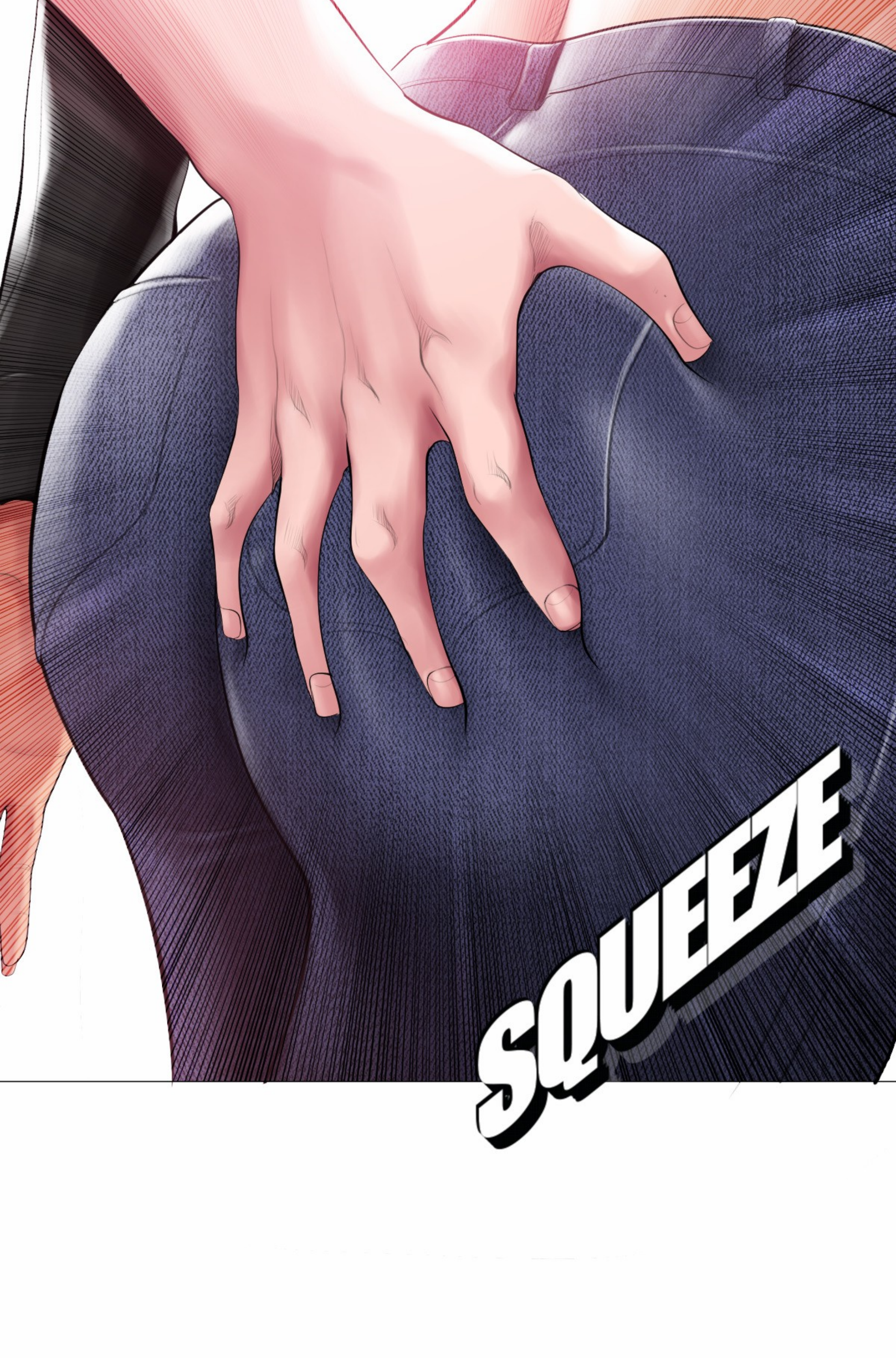
